Modification Details

Purpose: This modification is issued to remove references to Woman Owned Small Business set-asides and to include the DFARS clause concerning the safeguarding of unclassified information.

Modification:

1. For the NAICS code that is used in Seaport e (541330), the only woman owned set aside category that can be done is for the Economically Disadvantaged Woman-Owned Small Business. In Section H, paragraph C(1), this modification removes all references to Woman Owned Small Businesses as a category of set-asides available in Seaport e.

2. The following changes are made to the "Clauses Incorporated by Reference" in Section I:

Remove: FAR 52.219-30 Notice of Set-Aside for Women-Owned Small Business Concerns Eligible Under the Women-Owned Small Business Program (JUL 2013).

Add: DFARS 252.204-7012 Safeguarding of Unclassified Controlled Technical Information (NOV 2013).

3. All other terms and conditions remain unchanged and in full force and effect.
